# Abstract

In the face of crises such as the outbreak of Coronavirus disease and other events such as floods and earthquakes, one of the missing components in the urban management system is neighborhood-scale social support centers - social and participatory mechanisms for identifying the capacities and deficiencies of small local communities before crises, directing and leading interventions during crises, and assisting and helping recover after crises. Since such structures would not be possible without the support of government and urban management systems, investigating psychological and social impacts of crises such as the Coronavirus outbreak in cities like Tehran, both in terms of the tools and capabilities to contain the spread and the impacts on the relationship between citizens and the systems of governance and urban management, suggest the importance of focused and consistent social protection policies and programs on a local scale.

## Abstract

Cities function as complex and chaotic systems that seek to achieve a new order through tending to entropy. In this interactional context, urban space is expected to be reproduced in a relatively different way, and in this process, the relations between the centers of activity, habitation and space have evolved and establish a new pattern and behavior that can reproduce its own new space. The aim of this study is to discover the probable impacts of Coronavirus crisis on urban and regional space and on synergy of this interplay by the pattern of human relations and behavior in space. For this purpose, after reviewing historical documents and sources and observations resulting from lived experience, in an interview with a group of experts and specialists in this field, 50 of them were selected to conduct an online survey. The resulted average and the coefficient of variation of this opinion-poll showed that for all variables, the average was higher than 5, and therefore experts believe in a change in the future. However, the coefficient of variation indicates that among all variables there's a more consistent consensus on objectified changes in status quo. Therefore, besides developing immediate actions for some cases, long-term scenarios should be developed for other cases.

# Impacts of Coronavirus Covid-19 Pandemic on National Production Growth in 1399 SH

# Abstract

Understanding the Impacts of Covid-19 pandemic on the economy of Iran, especially on GNP and growth, is crucial to providing solutions. In this paper, analytical method is used to identify the problem by scenario writing. So, GNP and economic growth in 1399 SH, considering the impacts of Covid-19, other things being equal, were estimated in four different scenarios. The results show that production in the best case scenario, will have a growth rate of -4.17%. In the worst case scenario, growth can be reduced to -17.5%. In the two intermediate scenarios, growth rates are estimated -5.7% and -15.28% for economy of Iran. Based on the presented scenarios, two factors of government policy-making and public health are pivotal. So it is sugested that: the government should be technically considerate and careful in policy-making process, especially in compensating for the damage caused to economic structures and it should try to increase social capital in order to increase the degree of public conformity aligned with health and hygiene instructions and also performance of the economy in the country.

## Abstract

When a macro-level problem directly or indirectly affects the majority of people in a society, behaviors and attitudes would probably reflect the public attitude of society. In such conditions, researchers can provide policy makers with suggestions by identifying and studying collective attitudes and behaviors in different areas. Coronavirus epidemic created a social construct that can influence policy-making process in various fields. The aim of this paper is to study the social construct of coronavirus epidemic in Iran and the policies against it, among Internet users, in a period of 50 days (from the beginning of March to April 10, 2020). Thematic analysis was used to analyze the collected data in this qualitative research.
